1. Reason for filing

An event that materially impacts the financial position, operating results and cash flow condition of Japan Tobacco Inc. (JT) has occurred. Therefore, this document is filed pursuant to the provisions of Article 24-5, paragraph 4 of the Financial Instruments and Exchange Act and Article 19, paragraph 2, item 12 of the Cabinet Office Ordinance on Disclosure of Corporate Affairs.

2. Content of report

(1) Date of occurrence of the aforementioned event

(2) Detail of the aforementioned event

JT received a dividend of USD 1 billion (approximately JPY 136.8 billion) from its consolidated subsidiary, JT International Group Holding B.V.

(3) Impact of aforementioned event on profit/loss

The dividend income of USD 1 billion (approximately JPY 136.8 billion) will be recorded as non-operating income in JT's non-consolidated financial statements for the fiscal year 2022. However, as this dividend is received from its consolidated subsidiary, it will not have any impact on JT's consolidated financial results for the fiscal year 2022.
